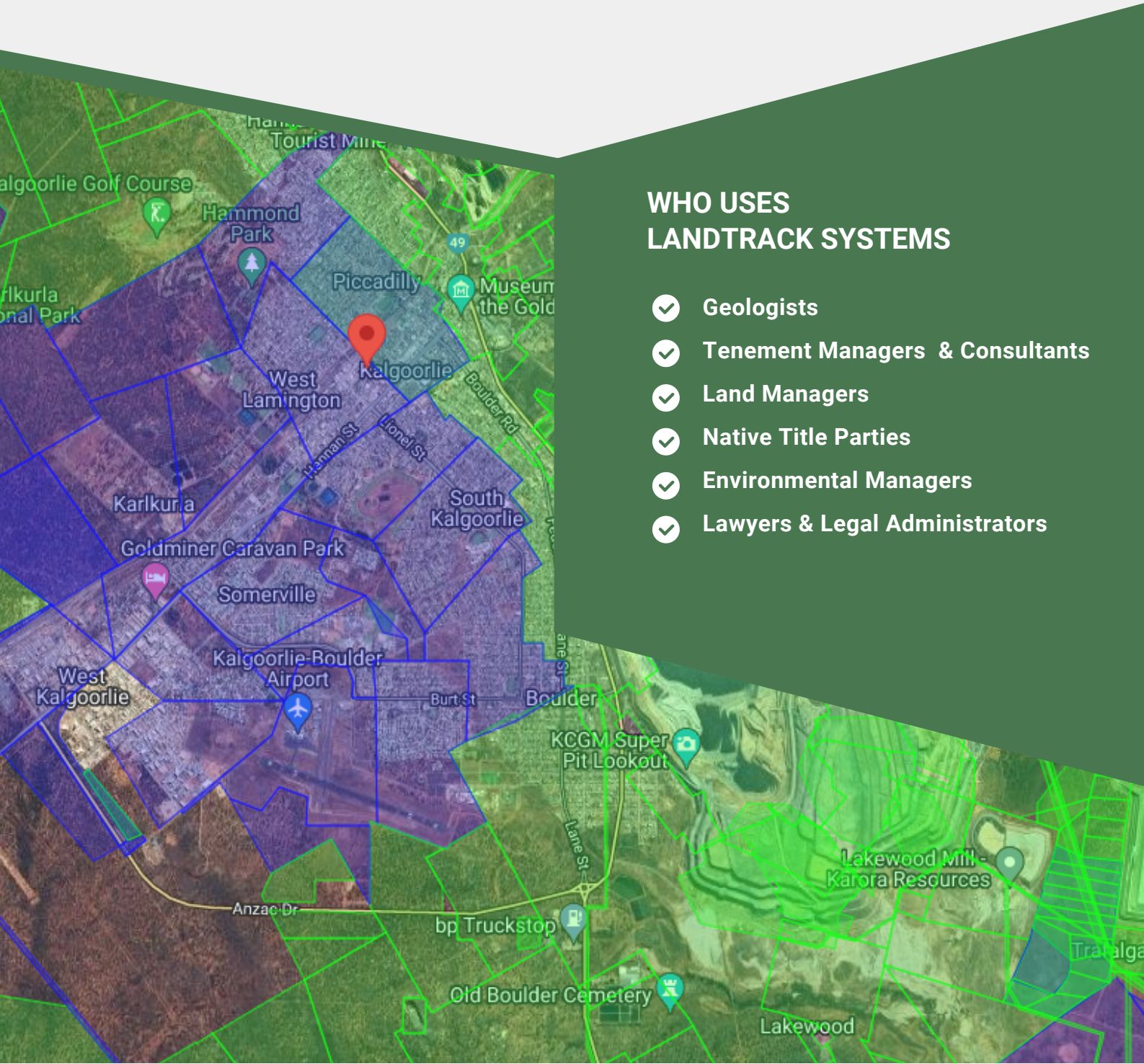

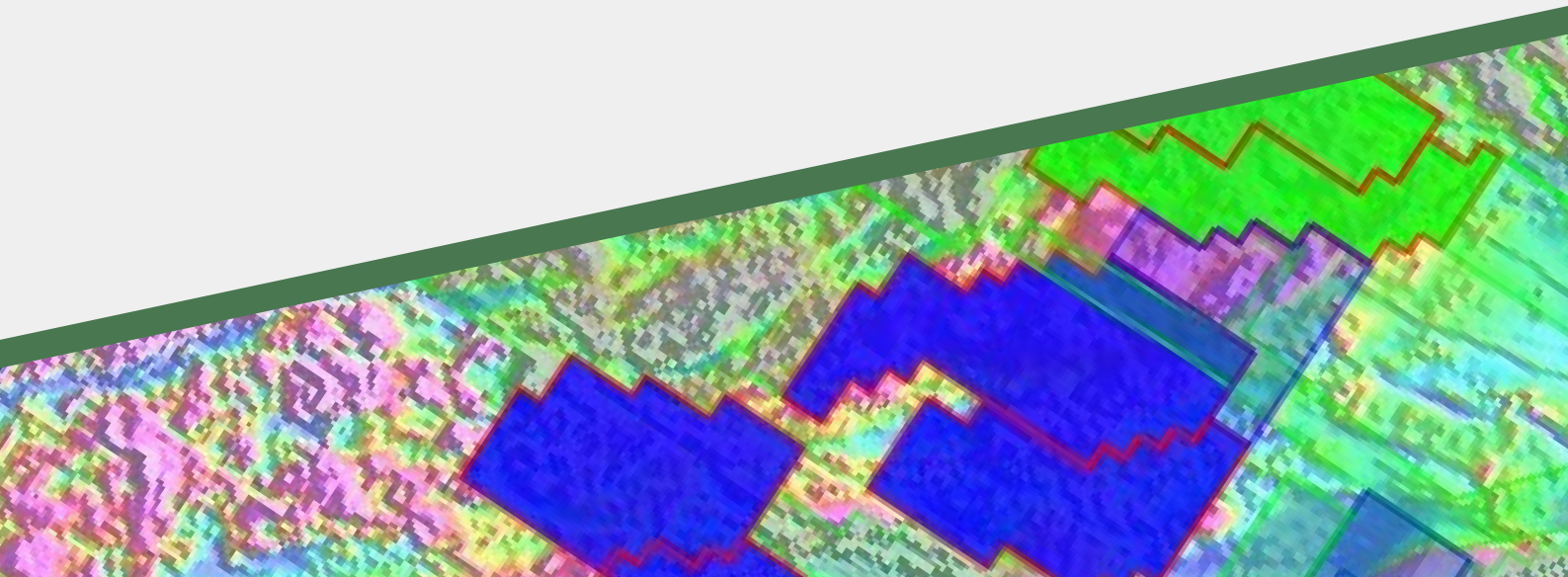

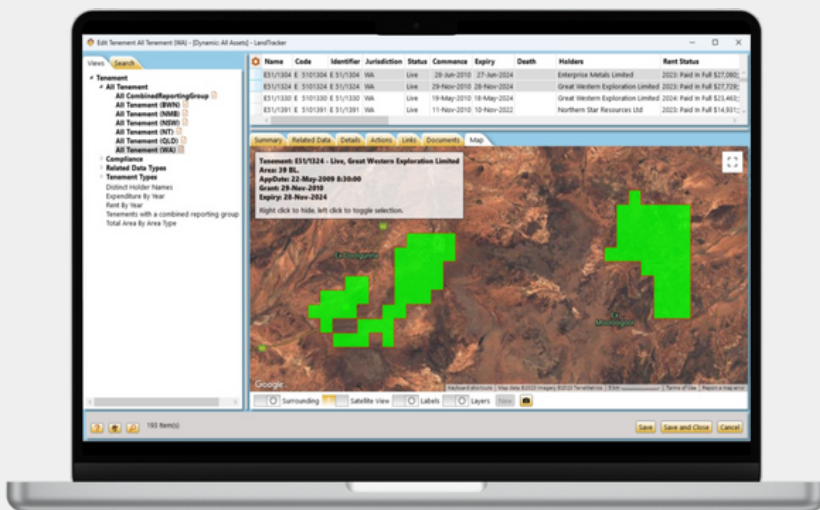

It provides up to the minute email alerts of newly available land by monitoring surrendered and withdrawn tenements and reporting on other tenement changes.

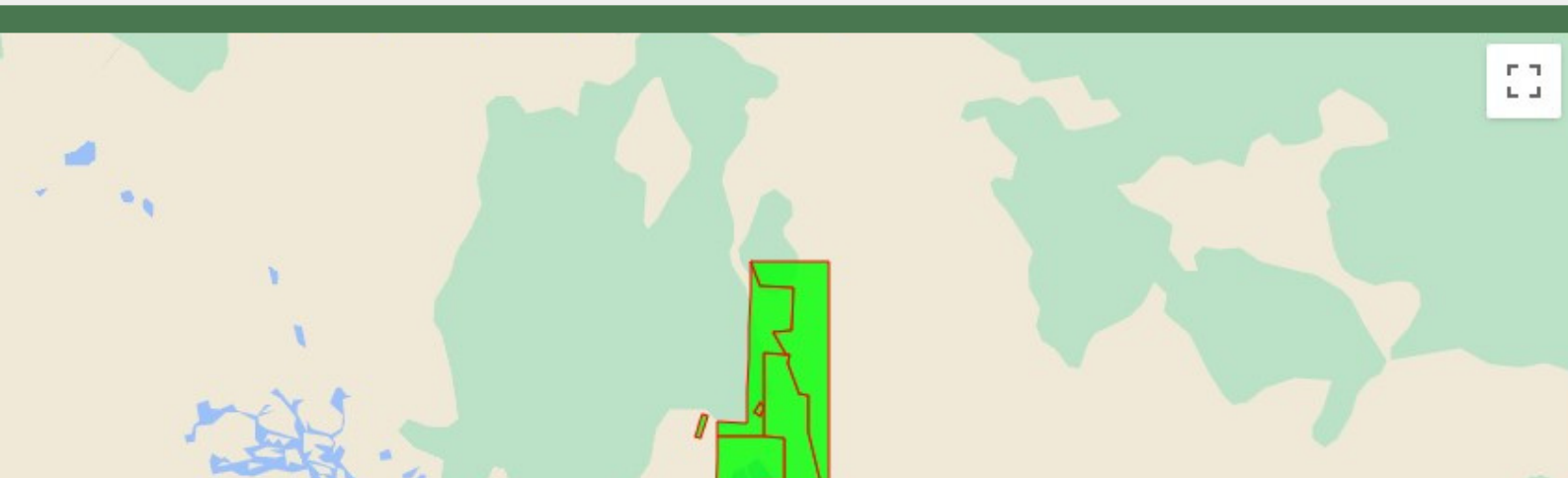
